At its meeting on **Monday, December 18, 2023**, after praying together, the Standing Committee took up, among others, the following matters:

- 1. Bishop-Elect Jeremiah Williamson** brought us up to date on the progress of his family's plans to relocate to the Diocese of Albany. Please pray for a smooth transition, closings on property sales in Colorado and the purchase of a house in Loudonville, and for travelling mercies.
- 2. Received an update** on plans for the Consecration, with the highest possible priority focus on acoustics in the Cathedral and streaming of the event. A detailed plan has been developed and bids are being solicited.
- 3. Approved** the minutes of the December 4, 2023, Standing Committee meeting.
- 4. Were informed** of developments in Child Victim Act lawsuits in which the diocese is named as co-defendant.
- 5. Renewed** the license of the Rev. Sally Heilgman to officiate in the Diocese of Albany for one year.
- 6. Granted letters dimissory** to the Rev. Carolyn Bartkus to the Diocese of Dallas.
- 7. Resolved** other clergy issues.
- 8. Accepted** the retirement of the Rev. David Ousley as Dean of the Northern Adirondack Deanery, and thanked Fr. David for his leadership and service in that role.
- 9. Appointed** the Rev. Andrew Cruz Lillegard Dean of the Northern Adirondack Deanery.
- 10. Consented** to the election of the Rev. Austin Keith Rios as Bishop Coadjutor in the Diocese of California.
- 11. Received the report** of the Administration subcommittee on work being done to ready properties on South Swan Street for future use by the Bishop.
- 12. Learned** of progress in arrangements to hold the next annual Diocesan Convention in person at the Silver Bay YMCA facility.
- 13. Heard a report** on matters before the Trustees of the Diocese, including progress on ADIT reform; proposed sales of parish properties; and contingency planning.
